## 8. New Business:

- a) Library Board Appointments for 2023: R. Martin and H. McLeod were approved by the DOI council.
  - Area G rep still needed on the board of trustees
  - H. McLeod shared job posting for the board on social media awaiting feedback from RDEK
- **b)** Library Board Chair and director met with CAO Andrew Young and Mayor Miller on January 30, 2023 to review the lease
  - There was positive discussion around revisions to the terms in the lease agreement
  - CAO Andrew Young will make changes to agreement and resubmit it to the board for review and signing at March 7/23 board meeting
  - There was detailed discussion of the clauses (e) (g) regarding in-kind expenses to be transferred to the library
  - D. McAffer requested a letter of guarantee from the DOI that there would be assistance with these costs in 2023
  - The DOI hopes that the RDEK will share the burden of the inkind expenses. To date, they have been covered 100% by the DOI.

- d) Social Media Marketing: H. McLeod presented plan to use library stats to effectively market the library and increase public support
  - For example, promote the fact that library programs are free
  - Programming is accessible to everyone
